NOTICE TO CONTRACTORS OF DITCH LETTING.

Notice is hereby given that sealed bids for the construction of the Richard A. Romine drain will be received by the undersigned, Charles U. Mohler, superintendent of construction of said drain at the office of the County Surveyor, Madison County, Indiana, at ten o'clock A. M. on Saturday, July 3, 1920.

Said ditch is to be a tile ditch throughout its entire length, consisting of 1,581 feet of 7 inch tile, 600 feet of 8 inch tile, 1,000 feet of 10 inch tile, 3,071 feet of 14 inch tile, and 83 feet of 16 inch tile. It is estimated that there are 1,886.50 cubic yards of dirt to be removed.

Contractor to furnish all labor and material necessary to construct said ditch in all things according to plans, profile and specifications; all tile to be good, smooth, well burnt, first class tile. Estimated cost of all labor and material required to construct said drain is \$2,208.68.

Bids must be accompanied by a certified check of \$100.00 to insure good faith that the successful bidder will at once enter into contract and bond for double the amount of his bid for the construction of said work and the performance of his contract.
